- Encourage employees to promptly report all incidents, accidents, near misses, and safety concerns. Thorough investigations will be conducted to prevent recurrence.
- Ensure employees are trained to undertake the tasks required.
- Ensure employees are empowered to delay or postpone any activity this is considered unsafe.
- Provide our employees with information on occupational health, health promotion and wellbeing.
- Encourage safe behaviour by all employees and subcontractors, including recognising and promoting safe behaviours as well as providing re-education relating to un-safe behaviours.
- Ensure all employees play an active part in the health and safety of the Company by consulting with them and providing them with adequate information, instruction, training and supervision for them to understand their role within the Company.
- Engage with our supply chain colleagues and contractors to ensure that their safety and health management standards and practices meet or exceed the expectations of this policy developing a culture and environment that promotes the prevention of injury and ill health.
- Integrate safety and health matters into our business decisions.
- Ensure customer and statutory requirements are adhered to on all our projects.
- Support employee health and well-being through initiatives that promote physical and mental health.
- Regularly consult with our workforce and provide mechanisms for them to provide their feedback and suggestions for improving our approach to health and safety
- Maintain a management system in line with the requirements of ISO 45001:2018.

This policy will be communicated to all our employees and organisations working on our behalf, displayed on all our sites, our offices, our intranet, and will be made available to third parties.

Britcon is committed to continual improvement in all its systems and procedures, ensuring that the Company sets specific health and safety objectives in each business stream. In striving for continual improvement, the policy and health and safety objectives shall be periodically reviewed to ensure they remain relevant and appropriate to the Company's activities and it complies with all current occupational health and safety legislation and best working practices.
